With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, २०२०, the Indian Medicine Central Council Act, १९७० (४८ of १९७०) has been repealed with effect from the ११th day of June, २०२१. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (१) of section ३ of the Indian Medicine Central Council Act, १९७० (४८ of १९७०) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (३) of the section १ of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, २०२० has been come into force with effect from the ११th day of June, २०२१ and as per regulation ५९ (२) of The National Commission for Indian System of Medicine ACT, २०२०, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, १९७० and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, २०२० shall not be applicable.

- Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college, namely Maharashtra Arogya Mandals, Sumatibhai Shah Ayurved Mahavidyalaya, Sr No 165 A, Malwadi, Hadapsar Pune - ४११०२८, Maharashtra (Inst. ID: AYU0148) inspection of Your College was conducted on २५.०५.२०२३ & २६.०५.२०२३ on Hybrid mode as a part of annual visitation by the visitation team of Medical Assessment and rating Board, NCISM to process the Conditional permission with 60 seats in UG (BAMS) course and 78 seats in 13 PG Courses in the subject namely- (1) Ayurveda Samhita, Sanskrit and Siddhant - 06 seats (2) Kriya Sharir - 06 seats (3) Rasa Shastra & Bhaishajya Kalpana - 06 seats (4) Dravyaguna Vigyan - 06 seats (5) Rog Nidan-Rog Nidan avum Vikriti Vigyan - 06 seats (6) Agad Tantra avum Vaidikaya - 06 seats (7) Swasthavritta - 06 seats (8) Prasuti Tantra and Stri Roga - 06 seats (9) Kaumarbhritya - Bala Roga - 06 seats (10) Kayachikitsa - 06 seats (11) Shalya - 06 Seats (12) Shalakya - 06 seats (13) Panchkarma - 06 seats course and 05 seat in 01 PG Diploma Course namely - (1) Prasuti Evum Striropa - 05 seats for the academic session २०२३-२४ under section २८ of NCISM Act, २०२०.
- Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, २०१६", "The Indian Medicine Central Council (Post Graduate Ayurveda Education) Regulations, २०१६", provisions under the NCISM Act, २०२० and relevant Regulations there under.
- As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the ४७th Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on १३.०७.२०२३. On careful examination of the assessment report it is found that your college is fulfilling the notified & approved criteria, hence Board decided to issue the Conditional permission with 60 seats in UG (BAMS) course and 78 seats in 13 PG Course and 05 seat in 01 PG Diploma Course under section २८ of NCISM Act, २०२० for the **TRUE COPY** of the **2023-24**.

  - I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity with **60 seats** and 15% of postgraduate seats of the permitted intake capacity of **78 seats** in **13 PG Course and 15% of postgraduate diploma seats of the permitted intake capacity of 05 seat in 01 PG Diploma Course** shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2023-24 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/JTU. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/**NICISM for all India quota or the students admitted thereunder.**

III. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS(Fee)/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/JTU/Deemed to be University. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.

Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.

**The following requirements should be fulfilled by the college by 31<sup>st</sup> December, 2023 and send a compliance report to get permission for the session 2024-25:**

- i) all the requirements of Minimum Standard of Infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
- ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda).

iii) All the requirements of the Indian Council (Post Graduate Ayurveda Education) Regulations, 2016 for grant of permission to PG Courses.

iv) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto; and

The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2024-25






